About police and crime commissioners

On 18th July, you will be able to vote for your police and crime commissioner (PCC). The job of the PCC is to oversee the police and ensure that they are prioritising what matters to you.

Police and crime commissioners are elected by you to ensure the policing needs of your community are met as effectively as possible and to oversee how crime is tackled in your area.

The PCC in your area holds your police force to account for delivering the kind of policing you want to see. Their aim will be to cut crime and to ensure your police force is effective. PCCs bring a public voice to policing and they do this by:

- engaging with the public and victims of crime to help set police and crime plans;
- ensuring the police force budget is spent where it matters most; and
- appointing, and where necessary dismissing, the chief constable.

Work with others

PCCs also work with your council and other organisations to promote and enable joined up working on community safety and criminal justice.

The PCC does not 'run' the police force. Chief constables are responsible for the day to day operations of the police, but they are accountable to the public via the police and crime commissioner.

PCCs ensure an effective policing contribution alongside other partners to national arrangements to protect the public from other cross-boundary threats.

Represent the entire community

PCCs are required to swear an oath of impartiality when they are elected to office. The oath is designed so that PCCs can set out publicly their commitment to tackling their role with integrity. It reflects the commitment police officers make to serve every member of the public impartially and makes clear that they are there to serve the people, not a political party or any one section of their electorate.

About your vote

You need to be registered to be able to vote.

If you are not registered visit **www.gov.uk/register-to-vote** or contact your local council.

If you are registered, and eligible to vote you can either vote in person at a polling station, by post, or by proxy (allowing someone you trust to vote on your behalf).

Election statement:

I am the Lib Dem leader of the Opposition on Gateshead council (and a councillor since 1987).

The office of PCC has proved expensive, ineffective, and unnecessary. I support its abolition and returning police oversight to a board of councillor and community representatives.

Under the previous PCC, police numbers have fallen, crime rates have risen, and the police precept payable by council taxpayers has increased by the maximum - 21% last year - with no noticeable improvement in outcomes or police cover.

My priorities are:

- Neighbourhood policing
- Tackling the anti social behaviour affecting many communities.
- Reducing violence against and exploitation of women and children
- Tackling extremism and hate crime.
- Identifying joint solutions with mental health and social care providers to reduce pressure on police resources

- Reviewing the Late Night Levy and ensuring greater transparency on how it is spent.
- Supporting victims and encouraging restorative justice.
- Better resourcing for rural areas, including reopening police cells in Northumberland. Police cover is being depleted as officers from rural areas need to take detainees to Wallsend, since cells in the county were closed.
- Accessible justice via local courts
- Reducing reoffending rates
- Joined up working between police and local authority community safety provision, probation services, and youth offending teams.
- Emulating the approach taken by Durham Police on drugs policing. Drug use should be a public health priority rather than a police priority and police resources targeted at dealers not users.
- Effective action against prolific offenders and organised crime.
- Retention of the European Arrest Warrant and effective participation in European-wide initiatives on crime, terrorism, and extremism.

A vote for me at this election is a vote for common sense and effective community policing.
